### First aid measures

**SECTION 5. FIRE-FIGHTING MEASURES**

**Suitable extinguishing media:** Extinguishing media include dry chemical, alcohol foam, and carbon dioxide. Do not use direct stream of water. Water may be used to keep fire-exposed containers cool.

**Methods for containment and cleaning up**  
**Land spill:** Stop leak if you can do so without risk. Recover free product using non-sparking tools. Add sand, earth, or other suitable absorbent material to the spill area. Recover by pumping or with suitable absorbents. Dispose of in accordance with national and/or local regulations relating to waste disposal.

**Water spill:** Stop leak if you can do so without risk. Confine the spill immediately with booms. Remove from the surface by skimming or with suitable absorbents. Seek the advice of a specialist before using dispersants.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry place in tightly sealed containers. Store out of direct sunlight. Do not store near heat, sparks, open flame, pilot lights, static electricity, or other sources of ignition. Do not store where temperature may exceed 49°C (120°F). Store away from oxidizing agents. Rotate stock.
